2024 National Annual Member's Meeting (AMM) Highlights

This year's Presidents' Forum focused on the Strategic Plan for 2024-2027. Of special note, was a 2023's proposal (2307QC57G03) which was sent back to the National Board, which had been referred to the Governance Committee. This proposal was a proposed amendment that would make both the National President and the Chief Executive Officer positions bilingual. As a result of further discussions, it was resolved that only the Chief Executive Officer (CEO) would need to be bilingual.

<u>Some Excerpts from the Chief Executive Officer (CEO) Report:</u> Effective January 2024, the Association membership surpassed the 170,000-member mark. A survey conducted by Abacus Data confirmed that our membership overwhelmingly feels that our Association is on the right path so far. The survey revealed that a significant majority of members feel that their membership has positively impacted them.

Many responded on how the resources, services, advocacy initiatives and engaging communications channels provided by the Association are essential and valuable parts of their membership. The Association is investing in new technologies to improve the website, improve the communication channels and offering more tailored resources and programs that meet the specific needs of the membership.

The CEO reported on the Associations progress in communications, marketing and recruitment and on enhancing

Lunch 'n Learn Seminars in 2025

Estate planning is the process of making arrangements for the distribution and management of assets after death or incapacitation. It involves creating legal documents, such as wills, trusts, and powers of attorney. We are going to help you understand this process over three concurrent monthly sessions starting in May 2025.

The first session will cover what documents you need to gather up to determine what your financial landscape looks like by understanding your assets and liabilities. Do you need to plan beyond the demise of the pensioner and if so, how? There are two key takeaways: one, consider updating the information package yearly to keep it current; and more importantly, two, if you go to all the work of figuring where you are fiscally, then you should tell someone where you have stored the information.

The second session will dive into documents crucial to estate planning, wills and powers of attorney for property and health care. The session will also cover living wills, end-of-life plans, designating beneficiaries and finding an estate trustee (executor). The duties of an estate trustee will be outlined: what liabilities they take on and how to find and engage one.

The third session will examine the third document used in estate planning: trusts, covering their purposes and establishing if they are good fit for you. The session will look at taxes and how they impact on estate planning and inheritances.

We will review probate looking at how one should approach or forget about this form of taxation. We will delve a little into insurance coverage reviewing different types and their need in estate planning. To wrap it up we will have a look at what sort of team of advisors you should consider, or can you manage estate planning as a do-it-yourself project?

The current plan is to hold these Lunch 'n Learn at the Petawawa Legion but more details will be forthcoming and be publicised by handouts at the Branch Annual Meeting in April 2025 and through e-blasts, an effective means the branch has to reach out to members.
